FOR DISTINGUISHED SERVICE TO SQUARE & ROUND DANCING IN NEW ENGLAND

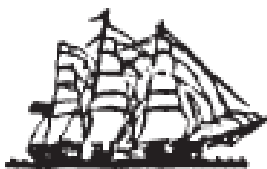
Nominations for the *Yankee Clipper Award for Distinguished Service to Square/Round Dancing in New England* will be judged upon the following criteria:

- a. The Nominee shall have been active a minimum of ten years in this New England activity.
- b. That during this time the dedicated service to square/round dancing has been of an exemplary nature.
- c. That the Nominee is a 'complete' person; that is, his/her total life brings credit to our activity.
- d. Normally this Award shall be considered a partner award. Service and activities of the partner when applicable shall be considered.
- e. Nominations shall be *confidential* and *not* discussed with the Nominee except as cleared by the Awards Committee in advance of such discussion.
- f. There shall be no announcement of the Award Recipient until the Award has been made publicly.
- g. The decisions of the Awards Committee are final, binding and not subject to review by any other authority.
- h. In making this Award, it shall be understood that the CO-Operation Committee is acting for square and round dancers in EDSARDA, callers in NECCA, and round dance teachers in NECORTA.
